**The minutes:** of the Meeting held on Tuesday 27<sup>th</sup> February 2024, had been circulated by e-mail and proposed by Martin Jackson and Seconded by Martin Fairburn.

## **Matters Arising from the Minutes.**

- Sport 80 –
  - New updates were circulated – MF to contact the ACU and obtain some information as many of the proposed updates are behind schedule.
- Confirmed that the insurance rates had been circulated and also a confirmation of the insurance rates for youths been at 50% but rounded up to the nearest penny.
- Ruus Brodie presented some options for the Centre Awards – Meeting decided on tall glasses.

- Request from the ACU to join a meeting with Yorkshire Combined Authority – West Yorkshire Mass Transit Phase 1 on 22<sup>nd</sup> April. MF attended interesting but not relevant to our operations.
- Email from ACU 20<sup>th</sup> March for request for information with reference the way forward proposals – ACU meeting to be held 6<sup>th</sup> April. MF sent a reply outlining the Centres intended activities,
- Minutes of the T and E commission meeting 14<sup>th</sup> February 2024. This has been forwarded to club secs – martin Jackson made a valid point that not all the relevant people received this information. MF will forward all minutes of ACU meetings to the relevant club and centre officials.

## **Centre Handbook:** -

- 50 copies have been printed – clubs in attendance collected copies for circulation.

## **President's floor:** -

- East Yorks and the Northern Centre discussion group
  - Peter Gregory contacted Martin Jackson who is part of the ACU way forward discussion group. It was disclosed that there were not many people on the group East Yorks have said that there is little Northern England representation.
  - Potentially there are a lot of detrimental proposals been put forward that we are not part of.
  - Dave Willoughby has suggested that the Northern Discussion Group should be perhaps resurrected so as we are better represented (For info this consists of - the Northern Centre, Northeastern Centre, The East Yorkshire Centre and of course us The Yorkshire Centre, this discussion group was previously formed to facilitate a gathering of people associated with centres within Northern England) . MJ to confirm with DW that we believe this would be a good idea considering the apparent agenda of the ACU.
  - Another meeting of the working group was due on the 6<sup>th</sup>, it has been said that in the North the focus of centres is trials and perhaps the management of trials should be left alone.
  - There are fears that the centres are been manipulated.
  - Chris Haigh said that we should be better represented, and it seems that the issue with the representation was peoples time – CH has said that he would be willing to attend the meeting providing there was an option to join remotely.

  - There is a resolution to re-appoint several directors en-bloc rather than as individuals. Martin Jackson to ask if the directors can be voted on separately otherwise MJ has the option to abstain should he feel this required.
